

# Cottage Street School PTO Membership Meeting Minutes from June 14, 2018

3. Treasurer's Report: Aparna reviewed income and expenses, report distributed.

### 4. Committee Updates:

- a) <u>Yearbook Update:</u> The yearbook was distributed to teachers today, but some teachers have not yet passed them out to students. Some great feedback was shared, particularly how bright and beautiful it is. It was pointed out that there seem to be candid pictures only from certain classes, despite efforts by Aparna and Mr. Madden to reach out to all teachers. Mr. Madden and Mrs. Frers are keeping a list of others who think they have already paid and working with Aparna to get it sorted out.
- b) <u>Scholarship Recipient:</u> Grant Fawcett is the scholarship winner this year. The application pool was super impressive. As Grant will be unable to attend 5<sup>th</sup> grade graduation, he will share a video of him reading his essay to be played that evening.

#### 6. New Business

- a) Playground Repainting this Saturday, June 16 from 9-2—Come for some of the time or all of the time. Kids are welcome to join you. They may order from Pizza Market for lunch if there are enough people. You can sign up on the SignUp Genius if you know ahead of time that you can make it. Or, just show up if you find yourself with free time.
- b) Artist in Residence—Someone asked when we will see the quilt made out of pencils. Mr. Madden is waiting to hear back about when we will get it.
- c) End of the year gifts—We approved the slate of year end gifts and restricted savings as described below:

The following items may be purchased for the school in the amounts not to exceed those stated in parentheses—vote on these as options, set estimates as high

- Risers for the cafeteria (\$5000)—the current ones are sagging
- Refrigerator for the teachers' room (\$2000)—we would like to buy a bigger refrigerator
- Storage container for the playground for recess equipment (\$1000) we would like to fill it with jump ropes, balls, hula hoops, etc.
- Materials to spruce up courtyard (\$1000)—umbrellas, plants, etc. to make it a more useable space—The Garden Club is wanting to get involved in schools and give back to the community, so we should check with them before purchasing anything
- Headphones for the library/computer lab (\$700)—there is an ongoing need for these

Additionally, the following monies will be set aside in restricted savings for next year:

- Drama Program (\$2000)—buy rights to play
- Teacher Appreciation Week (\$1000)—so we don't have to ask families for money

• Tax Preparation (\$1000)—to hire a tax professional to file taxes The remainder of all monies will be set aside in the Playground Reserve Fund—this money will help supplement what the town and school will provide when the time comes to replace the playground structure.

 d) Election of board for 2018-2019 school year—once the motion to nominate Emily Hollenbeck as President was approved, the motion to elect the full slate of officers was approved for 2018-2019 school year
